# Foreword

Total, being the only international oil company active in all branches of Qatar's oil and gas sector, has had an uninterrupted presence of close to 80 years in the country. Today their activities include exploration & production, refining & petrochemicals, and the marketing of lubricants.

In addition to operating the Al Khalij offshore field located 120 kilometres north-east of Doha, Total owns significant interests in the most prominent energy joint-ventures in Qatar, including Qatargas 1 & 2, Dolphin Energy which provides UAE and Oman with natural gas from Qatar; Ras Laffan Refinery, Qapco and Qatofin which was a joint venture to build the largest ethane cracker in the world.

Total bases its success to its experienced staff and highly respected technical expertise. It's involvement in the local community complements its extensive operational portfolio.

**H.E. Dr. Ibrahim Ibrahim** is the Economic advisor at Amiri Diwan and appointed as the Secretary General for the General Secretariat for Development Planning. Dr Ibrahim sits on a number of Boards; Vice Chairman at RasGas and Qatar Gas Companies Limited, Qatar Development Bank; and as member of Qatar Central Bank, Qatar Foundation Advisory Board, Qatar Petroleum and Supreme Council for Economic Affairs and Investment. He served as Associate Professor Business, Economics and Quantitative methods at University of Hawaii, Director of OAPEC and Senior Economist at Oxford Institute for Energy Studies. Dr Ibrahim holds a Ph.D. from New York University and is recipient of awards from Abdulla Bin Hamad Al-Attiyah, MEED, Oil & Gas Magazine, CWC World Energy Summit, Qatar International Business Women Forum and National Human Rights Committee (UN).



**Dr. Daniel Yergin** is Vice Chairman of IHS and Founder of IHS Cambridge Energy Research Associates. Time Magazine said, "If there is one man whose opinion matters more than any other on global energy markets, it's Daniel Yergin." A Pulitzer Prize winner for his book *The Prize*, Dr. Yergin is the author of the new bestseller *The Quest: Energy, Security, and the Remaking of the Modern World*, which *The Economist* called "masterly" and the *Financial Times* declared "a triumph". Of Dr. Yergin's book *Commanding Heights: the Battle for the World Economy*, the *Wall Street Journal* said, "No one could ask for a better account of the world's political and economic destiny since World War II." In 2014, India's Prime Minister Manmohan Singh presented Dr. Yergin a Lifetime Achievement Award. Dr. Yergin holds a B.A. from Yale University and a Ph.D. from Cambridge University, where he was a Marshall Scholar.



**Dr. Aldo Flores-Quiroga** is Secretary General of the IEF since January 2012. Before joining the IEF Dr. Flores-Quiroga served in the Mexican government as Assistant Secretary for International Affairs at the Ministry of Energy, and as Assistant Secretary for Bilateral Economic Relations at the Ministry of Foreign Affairs. He was also a professor of political economy at the Claremont Graduate University in California. He studied Economics at the Autonomous University of Nuevo León, in Mexico and earned his Ph.D in Political Science-International Political Economy, at the University of California, Los Angeles.



**Dr. Shihab-Eldin** is Research Associate of the Oxford Institute for Energy Studies, and member of the Board of Directors of the Schlumberger SBC Energy Institute and member of the International Advisory Board of the King Abdullah Petroleum Studies & Research Center. He was Director at Department of Technical Co-operation at IAEA, Director of Regional Office, and Thrice of Representative at UNESCO. In addition to serving as Director General of Kuwait Institute for Scientific Research, Vice Rector for Academic Affairs and Physics Professor at Kuwait University, he was Research Physicist at Lawrence Berkeley National Laboratory in the USA. Dr. Shihab-Eldin is the Director General of Kuwait Foundation for Advancement of Sciences and former Board Member, and was Acting Secretary General & Director of Research, OPEC. Dr. Shiba-Eldin received a B.Sc., M.Sc. and Ph.D. (Nuclear Engineering) from University of California. He has lectured and researched at Kuwait University, the Lawrence Berkeley National Laboratory, the University of California, European Nuclear Research Center, Energy and Environment Policy Center at Harvard University, Belfer Center for Science and International Affairs, MIT, and Vienna Business School.

**Nobuo Tanaka** is President of The Sasakawa Peace Foundation as of April 1st, 2015. As Executive Director of the International Energy Agency (IEA) from 2007 to 2011, he initiated a collective release of oil stocks in June 2011. He also played a crucial and personal role in the strengthening of ties with major non-Member energy players, including China and India. He began his career in 1973 in the Ministry of Economy, Trade and Industry (METI), and has served in a number of high-ranking positions, including Director-General of the Multilateral Trade System Department. He was deeply engaged in bilateral trade issues with the US as Minister for Industry, Trade and Energy at the Embassy of Japan, Washington DC. He has also served twice as Director for Science, Technology and Industry (DSTI) of the Paris-based international organization, OECD.



**Professor Tan Chorh Chuan** is President of the National University of Singapore. He concurrently serves as the Chairman of the Board of the National University Health System, Deputy Chairman of Singapore's Agency for Science, Technology and Research, and Director of Monetary Authority of Singapore. He is the Chair of the World Economic Forum's Global University Leaders Forum and a member of the Forum's Global Agenda Council on the Future of Jobs. He is a Fellow of the Royal College of Physicians of London and of Edinburgh, American College of Physicians and Royal Geographical Society, UK.

- Nominee Selection Process -

## GUIDELINES FOR THE SELECTION OF SUCCESSFUL AWARD WINNERS

This is open to an individual with an outstanding record of achievement in the advancement of the international energy industry and/or energy policy, but should not currently be an executive employed by an International Oil Company.

Nominees may come from a variety of backgrounds, including academic, political, technical, industry, business or media fields. A strong candidate will have made an exceptional impact on their field with distinct personal achievements over at least three decades. They should be an inspirational individual, and through their contribution and/or leadership, their work will have reached far beyond their own actions and affected people, companies and/or nations.

*Key Criteria for Nominees to Make it On to 5-Person Shortlist in Each Category:*

### 1. Impact

- An outstanding record of accomplishment in their sector over the whole of a career.
- Clear, significant and sustained positive impact in their sector over many decades.
- Demonstrated commitment to further the advancement of the energy industry as a whole, for example through advocacy, stakeholder engagement, international partnership, education, media, and standards development.

### 2. Leadership & Partnership

- Widely recognized as an outstanding and inspirational figure in their field, with much of the impact attributable to this individual having been brought about through other people, as a result of the candidate's qualities.

### 3. Innovative and Creative Thinking

- Clear individual contribution to the development of innovative solutions, services or initiatives with tangible benefits.

### 4. Long-Term Vision

- An exceptional impact on the energy industry with distinct personal achievements for a consistent and prolonged period of engagement.
- Clear vision for the long-term future of energy and its place and role in the world, which drives on-going work and new initiatives.

## SELECTION PROCESS

**Step 1:** A group of internationally renowned energy figures, including former winners of the Al-Attiyah Awards, are invited each year to join the volunteer Selection Committee.

**Step 2:** The 7-person International Selection Committee and the awards producer submit nominees that meet the above criteria for the five award categories -- Qatar; OPEC; Producer-Consumer Dialogue; Education; Journalism -- which delivers a shortlist of five nominees for each category.

**Step 3:** The 7-person International Selection Committee independently scores every nominee in each of the five Award categories for their performance on each of the above 4 Criteria.

**Step 4:** The scores of the 7-person Selection Committee are aggregated and the nominees are ranked in accordance with their total points tally.

**Step 5.** His Excellency Al-Attiyah each year selects one additional outstanding individual to receive an Honorary Lifetime Achievement Award for the Advancement of International Energy Policy & Diplomacy.

His Excellency Abdullah Bin Hamad Al-Attiyah is the Chairman of Abdullah Bin Hamad Al-Attiyah Foundation for Energy & Sustainable Development. Formerly, he was the President of the Qatar Administrative Control and Transparency Authority as well as the President of COP18/ CMP8 Doha and the Chairman of the Higher Organizing Committee.

H.E. Al-Attiyah, born in Qatar in 1952, has more than 30 years' experience in the energy industry and has held a variety of senior leadership positions within the government of Qatar. In 1992, H.E. Al-Attiyah was appointed Minister of Energy & Industry and Chairman & Managing Director of Qatar Petroleum, before being entrusted with the additional responsibility of Second Deputy Prime Minister in 2003. Four years later he was promoted to Deputy Prime Minister and, in 2011, was appointed Chief of the Emiri Diwan.

H.E. Al-Attiyah has served as Chairman of Qatar's Planning Commission and was elected Chairman of the United Nations Commission on

Sustainable Development in 2006. Currently, he serves as Chairman of the Board of a number of organizations, including Qatar General Electricity and Water Corporation, which among other environmental projects, is exploring the use of solar energy for electricity supplies.

During his illustrious career, H.E. Al-Attiyah, who is also on the board of directors of Gulf Air, has received a number of awards and honors including the Grand Cross in the Order of the Orange Nassau, conferred by Queen Beatrix of the Netherlands, and the Grand Cordon of the Order of Rising Sun, awarded by Emperor Akihito of Japan in recognition of H.E. Al-Attiyah's contribution to promoting bilateral relations between Qatar and Japan.

H.E. Al-Attiyah was also conferred the Necklace of Independence award by His Highness Sheikh Hamad Bin Khalifa Al-Thani, the Emir of Qatar, for his work in championing Qatar's commitment to transparency in business and governance, and for his efforts to promote the national economy.

Nasser Khalil Al-Jaidah  
*CEO, QPI*

Mr. Nasser Al-Jaidah joined Qatar Petroleum in 1977 after graduating with a degree in Geology and Petroleum Engineering.

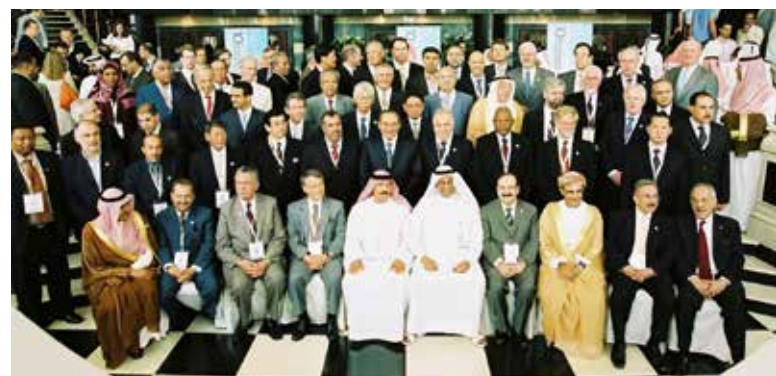

Mr. Al-Jaidah is also a board member of Qatargas and Vice Chairman of the Qatargas Executive Committee, Vice-Chairman of Qatar Fuel Additives Co., Vice Chairman of Tasweeq and a Board Member of Industry Qatar. He is a

# Lifetime Achievement Award for the Advancement of the Organization of Petroleum Exporting Countries

Dr. Ramzi Salman

*Former Deputy Secretary General, OPEC*



Dr. Ramzi Salman began his professional career lecturing at Baghdad University in 1962, before joining the Iraq National Oil Company (INOC) and heading the petroleum engineering sector until the nationalisation of the Iraq Petroleum Company (IPC) in 1972. Thereafter, Dr. Salman worked on establishing SOMO, the state oil marketing organisation, and served as CEO for 20 years. Relocating to Vienna in 1991 as Deputy Secretary General of OPEC serving two consecutive terms. Dr. Salman's last professional relocation was to Doha in 1997, as senior advisor to the Minister of Energy and CEO of Qatar Petroleum (QP).

Dr. Salman was decorated by the Republic of Brazil for his role in developing its bilateral relations with Iraq. He was also decorated by the Republic of Austria for his contribution towards strengthening OPEC–Austria relations and his collaborations during his time working in Vienna.

Dr. Salman has first-class honours BSc in Petroleum Engineering and a PhD in Chemical Engineering, both from the University of Birmingham. He is an honorary fellow in the Centre for Petroleum and Mineral Law and Policy at the University of Dundee.

Dr. Salman was instrumental in the establishment of the Petroleum Engineering Department at Baghdad University, INOC and SOMO during his time in Iraq. He represented Iraq on OPEC's Board of Governors and on several other international forums.

Dr. Ramzi Salman, has been involved in the oil industry for more than half a century. Currently, Dr. Salman resides in Ireland with his wife and extended offspring. Spending his days learning the new from his next generation but yet still admiring the oil scene from afar, not helping himself ponder why we don't learn from history...

He was an active participant and contributor to the IEF (International Energy Forum) since its foundation and was Qatar's representative on its board until 2013; as well as being the secretary of Qatar National Committees for the World Petroleum Congress and World Energy Council until 2011.







# Lifetime Achievement Award for the Advancement of Producer-Consumer Dialogue

Dr. Fatih Birol

*Chief Economist & Director, Global Energy Economics,  
International Energy Agency*

Dr. Fatih Birol is the Chief Economist of the International Energy Agency in Paris. He is responsible for the IEA's flagship World Energy Outlook publication, which is recognized as the most authoritative source of strategic analysis of global energy markets. He is also the founder and chair of the IEA Energy Business Council, which provides a forum to enhance cooperation between government and industry.

Dr. Birol has been named by Forbes Magazine among the most powerful people in terms of influence on the world's energy scene. He is the Chairman of the World Economic Forum's (Davos) Energy Advisory Board and has served as a member of the UN Secretary-General's 'High-level Group on Sustainable Energy for All'. He is the recipient of numerous awards from government and industry for his contribution to energy and climate economics. Most recently, in 2013, he received the Japanese Emperor's Order of the Rising Sun, the country's highest honour. He has also been

decorated by the governments of Austria (Golden Honour Medal), France (Chevalier dans l'Ordre des Palmes Académiques), Germany (Federal Cross of Merit), Iraq, Italy (Order of Merit of the Republic), the Netherlands, Poland, Turkey, the United States and the Russian Academy of Sciences. He is a past winner of the International Association of Energy Economics' award for outstanding contribution to the profession.

Prior to joining the IEA in 1995, Dr. Birol worked at the Organisation of the Petroleum Exporting Countries (OPEC) in Vienna. A Turkish citizen, Dr. Birol was born in Ankara in 1958. He earned a BSc degree in power engineering from the Technical University of Istanbul. He received his MSc and PhD in energy economics from the Technical University of Vienna. In 2013, Dr. Birol was awarded a Doctorate of Science honoris causa by Imperial College London. He was made an honorary life member of Galatasaray Football Club in 2013.





# Lifetime Achievement Award for the Advancement of Education for Future Energy Leaders

## Professor Giacomo Luciani

*Executive Master in Oil & Gas Leadership, IHEID, Geneva and Master in International Energy, PSIA, SciencesPo, Paris*

Giacomo has had a non-conventional teaching career. He has never held a full-time academic job, but always combined teaching with policy research, consulting or jobs in the oil and gas industry. He believes that this is the key to ensuring the relevance of his teaching.

Giacomo studied at the Universities of Rome, Yale and Harvard. He first became acquainted with the problems of the international oil industry while at Harvard, when he took the course jointly offered by the MIT, the Harvard Graduate School and the Harvard Business School

He began his career as an economist at the Bank of Italy (1972-74), the Bank's main analyst for oil price developments. In 1974 he left for the IstitutoAffariInternazionali (IAI).

In 1986 Giacomo moved to Los Angeles where he taught in the Economics Department at UCLA as visiting professor from 1986 to 1988. In 1988 he left Los Angeles for Riyadh to consult on Saudi Arabia's economic development. He left Riyadh in 1990, but continued to consult on Saudi economic development issues until 2009.

From 1990 to 2000 he worked for ENI, the Italian Oil Company during which time he also taught at Sciences Po in Paris from 1994 to 1997 and, from 1997, at the Bologna Center of the School of Advanced International Studies of Johns Hopkins University. In Bologna, where he taught until 2010, he began offering his flagship course on the Politics and Economics of International Energy.

In June 2000 he left ENI for the European University Institute in Florence. In 2006 he moved to Geneva, and in 2009 started offering his course on Politics and Economics of International Energy at the Graduate Institute of International and Development Studies in Geneva.

In 2010 he was called to establish a Master in International Energy at the newly established Paris School of International Affairs of Sciences Po. The Master, with an entirely original curriculum and attracting as faculty many of the best European experts in the field, accepts approximately 60 students per year from all over the world.

In 2010 Giacomo, in association with John Gault and Alexander van de Putte, started working on the establishment of a Master of Advanced Studies (Executive Master) in International Oil and Gas Leadership at the Graduate Institute of International and Development Studies in Geneva. Since then, this Master has completed three cycles in Geneva and was once offered in house to a select group of managers of a major Gulf National Oil Company.

In January 2015, Giacomo launched a MOOC (Massive Open Online Course) entitled Politics and Economics of International Energy, which had 4'000 students enrolled.

From 1976 to 1985, he was Deputy Director of the Arab Petroleum Research Center, Paris.

From 1982 to 1987, he lectured in Petroleum Economics (subjects: E&P contracts; OPEC) at the Université de Grenoble, France.

Dr. Terzian has published three books:

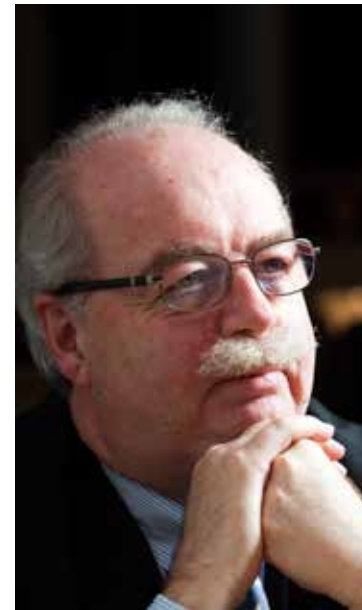

East is where I came into my own,” he would later confide.

Born on 6th August 1951 in France’s Vendée region, Christophe de Margerie started his career at Total in 1974, immediately after graduating from the École Supérieure de Commerce business school in Paris. He used to say that he chose Total not out of a love for oil, but because it was the company closest to where he lived. He would end up spending 40 years - his entire career - there.

Four years after that he was appointed President, Exploration & Production at Total. In 2000, after the creation of TotalFinaElf following Total’s merger with PetroFina and then Elf, Christophe became Senior Executive Vice President, Exploration & Production.

Having served as President of Exploration & Production since January 2002, he was elected Total Director during the Annual Shareholders’ Meeting convened on 12 May 2006.

Christophe held a number of positions in Finance and in Exploration & Production at Total, following which he was appointed President, Total Middle East in 1995. During his tenure there, he acquired unsurpassed negotiating skills, winning several contracts for the company. “The Middle
